NOTICE OF [Extra3]

Buist Byars & Taylor LLC (“BBT”) writes to inform you of an incident that may involve some of your information. While we are unaware of any actual or attempted identity theft or fraud in relation to this incident, we are providing you with information about the incident, our response, and resources available to you.

What Happened? BBT has been working with third party specialists to investigate an incident involving unauthorized access to its systems. The investigation determined that certain files stored in the BBT computer environment were accessed or copied without authorization between February 9, 2026 and February 13, 2026, as the result of a cyber event. Following the investigation, BBT undertook a detailed review of the involved files to determine what information was present in these files and to whom it relates. This review was completed on or about July 16, 2026, and BBT is notifying individuals in an abundance of caution.

What Information Was Involved? The following types of your personal information may have been present in the impacted files: your name and [Extra1].

What We Are Doing. BBT takes the confidentiality, privacy, and security of information in its care very seriously. In response to this incident, BBT conducted a diligent investigation, took prompt steps to ensure the security of its network environment, and conducted a comprehensive review of the information potentially affected. BBT also notified law enforcement and enhanced its existing security protocols and procedures related to data privacy and security.

As an added precaution, we are offering you access to [Extra2] months of credit monitoring services through **Experian** at no cost to you. We encourage you to enroll in these services, as we are not able to act on your behalf to enroll you. Please review the instructions contained in the attached *Steps You Can Take to Help Protect Your Personal Information* for additional information on these services.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. You may also enroll in the complimentary identity monitoring services we are offering. Please note that, due to privacy restrictions, we are unable to automatically enroll you in the complimentary monitoring services. Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
