Hampton Regional Medical Center (“HRMC”) is writing to notify you of a recent event that may involve some of your information. This letter provides you with information about what happened, our response, and steps you may take to help protect your information, should you feel it appropriate to do so.

What Happened? On January 6, 2026, we completed our investigation of an event involving unauthorized access to our computer network. Working with third-party cybersecurity specialists, we determined that between June 18, 2025 and July 16, 2025, an unauthorized actor accessed certain systems and may have accessed or copied certain files without permission. After identifying the files that were involved, we completed a review of the files to determine what information was contained in them, and to whom the information related. Based on the results of this review, we are notifying potentially affected individuals.

What Information Was Involved? Based on our review, we identified that the accessed and/or copied files included your name and the following types of information: [REDACTED]

What We Are Doing. In response to this event, we promptly took steps to secure our computer network and conduct a thorough investigation. We also published formal notification of this matter on our website in September 2025 advising of our ongoing investigation. Following the completion of our review, we are notifying individuals to ensure they are aware of this matter. Additionally, we are providing individuals with free resources and guidance, including identity monitoring services for 12 months through Experian. While no safeguards can fully prevent all cybersecurity matters, as part of our ongoing commitment to information security, we are also reviewing our existing policies and procedures and implementing additional administrative and technical safeguards.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. To assist with this process, you may review the “Steps You Can Take to Help Protect Personal Information” section of this letter, which has free resources and guidance on how to monitor and protect personal information. Further, you may enroll in the complimentary identity monitoring services we are offering. The enrollment instructions can be found in the “Enroll in Monitoring Services” section of this letter. Please note, due to privacy restrictions, we are unable to automatically enroll you in the monitoring services.

Enroll in Monitoring Services

To help protect your identity, we are offering a complimentary 12-month membership of Experian's IdentityWorksSM. This product provides you with superior identity detection and resolution of identity theft. To activate your membership and start monitoring your personal information please follow the steps below:

Please note that this Identity Restoration support is available to you for 12 months from the date of this letter and does not require any action on your part at this time. Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to consumers' files is limited; consumers must give consent for credit reports to be provided to employers; consumers may limit "prescreened" offers of credit and insurance based on information in their credit report; and consumers may seek damages from violators. Consumers may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active-duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
