Consumers may come with questions or complaints regarding a business between 10:00 a.m. and 1:00 p.m. Individuals are encouraged to bring documentation with them.

Outreach Coordinator Patty Guthrie will have additional materials available on holiday scams. During this busy shopping season, the Department has received many reports of gift card scams, secret shopper scams, and other fraudulent activity. "With all the shopping going on this time of year, scammers are particularly active in trying to gain bank account information or steal a few thousand dollars. Consumers should be especially cautious this time of year, especially given the current economy," said Ms. Guthrie.

The Department will continue to visit the Gaffney community on a regular basis. Locations will be announced monthly. The Department services the entire state via telephone and online help.
